TERMS OF CONSIGNMENT:

Consignment items may be dropped off with us at anytime during regular store hours or by appointment.

Consigned items must be:

- New or gently worn/used
- Clean (laundered/no mud on tack, blankets or boots)
- In good condition (clothing must have no rips, tears or major stains)
- Clothing must be in season or in style to be marketable
- Tack not dry rotted or broken

All items will be inspected by our staff and will be taken in based on our experience of whether the product will be marketable. We may suggest you bring it back at a later date due to seasonality. **SecondLook Saddlery, LLC** may refuse any item(s).

PRICING OF CONSIGNED ITEMS:

We do research on every item and price it according to what the market will bear. If you have a specific sales price in mind please let us know. We will do our best to accommodate you, however, all prices are set at our discretion. Keep in mind that on average most new items depreciate 50% off of their initial value the second you walk out of the store with them (and that's before wearing or using the item!) However, the resale value does depend on the brand, condition and type of item.

No membership fee or an annual fee charged.

Saddle consignment sales are: for saddles that sell **over \$500** the split is 30% (Second Look Saddlery) 70% (consignor); for saddles that sell **under \$500** the split is 35% (Second Look Saddlery) 65% (consignor)

All other items are a 50/50 split

Items (with the exception of saddles) are consigned for 6 months (180 days), after which the consignor will have the choice to renew the item, at a lower price, or retrieve the item. If the consignor choses to retrieve the item they will have a 10-day grace period, if items are not picked up during this grace period they become the property of **Second Look Saddlery, LLC** and may be subject to discount pricing or donation to charity for which **Second Look Saddlery** receives all monetary benefits.

Saddles may be consigned for 1 year.

It is the responsibility of the consignor to keep track of consignment contract expiration dates.

We will not call you when your item sells, but you may call periodically to check on your account balance.

Account balances may be used as store credit anytime for which you will receive an additional 5% on your store credit.

Checks may be picked up or mailed for a \$1.00 service fee please call us to have checks mailed.

Any item removed by consignor before the contract expiration date will be charged a \$5.00 processing fee.

TRIAL USE BY PROSPECTIVE BUYERS—NORMAL WEAR & TEAR

Consignor also understands that in order for **Second Look Saddlery, LLC** to sell any consigned item(s), it may be necessary to allow it to be used & tested off the store premises by horse and/or rider before it can be sold, & that **Second Look Saddlery, LLC** shall be authorized by you to allow such off site use & testing, on behalf of Consignor, for a period not to exceed two (2) days. In order to protect both Consignor and **Second Look Saddlery, LLC** & insure the return of item(s) to the store after the testing period, a verified credit card or cash transaction will be completed. **Second Look Saddlery, LLC** will not be held responsible for the normal wear & tear on any item(s) left in the store, which are to be sold on consignment. **Second Look Saddlery, LLC** is not responsible for any normal wear & tear, which results from that usage or testing of the item by the customer during said period.

Items may be covered under your homeowners insurance policy.

SALE FOR CASH, OR BY CREDIT CARD

During the term of this Agreement, **Second Look Saddlery, LLC** will use its best efforts to sell all consigned items on behalf of consignor, but shall only be required to contact consignor in the event an offer is made on consigned saddle for less than the listed & agreed upon selling price. Verbal or email acceptance of lower price is acceptable. All sales will be paid for by cash, or credit card.

MAINTAINING THE CONDITION OF CONSIGNED PROPERTY

Second Look Saddlery, LLC shall have no obligation or responsibility for maintaining the condition of consigned item(s) while they remain unsold. Specifically, consignor understands & accepts that because most consigned items are in a previously used condition, if they are left unsold for any length of time, they may become less sale-able or even unsalable, or any numbers of reasons, through no fault of **Second Look Saddlery, LLC**. At the same time, & during the term of this Agreement, if an item becomes worn, dried, cracked or broken, so as to make it unsalable, that condition will be brought to the attention of consignor. In the event of either happening, **Second Look Saddlery, LLC** will not be liable or responsible for those items, & no payment or other compensation to consignor will be made by **Second Look Saddlery, LLC**.

Second Look Saddlery will not accept responsibility for damages to or destruction of merchandise on consignment which should occur as a result of fire, flood or other major events outside the control of **Second Look Saddlery**. The consignor agrees to hold **Second Look Saddlery** harmless for these events.

This consignment contract is non transferable and is between you the consignor and **Second Look Saddlery, LLC**.
